Motion to Approve Abandonment of Street Right of Way.

C. Background

The Alexander House located at 206 South Main Street was acquired by the City in August 2015. When the property was surveyed it was discovered that the street right of way extended onto the lot by about 1.7 feet. This is inconsistent with the remaining right of way the City has along South Main Street. As a result the right of way encroaches on the property intended to be sold for the Demonstration Project. This portion of the right of way serves no purpose for the City street system. The developer has asked for it to be abandoned to clear title. City staff agrees that it should be abandoned.

RESOLUTION ABANDONING PUBLIC STREET RIGHT OF WAY

WHEREAS, the City of Kannapolis is the owner of approximately 2.737 acres of real property located on the west side of Main Street and the east side of West Avenue commonly referred to as the Demonstration Project site (the "Project Site"); and

WHEREAS, the City owns a small street right of way located on a portion of land anticipated to be conveyed as part of the Project Site; and

WHEREAS, the street right of way is no longer needed, used by or of benefit the City street system; and

WHEREAS, the developer of the Demonstration Project has requested that the City release and abandon the street right of way which encumbers the Project Site; and

WHEREAS, the portion of the street right of way involved measures 2.22 feet by 82.18 feet and contains a total area of 163 square feet (lines A1-A4) is shown on the plat ("Plat") attached to and incorporated into this Resolution.

NOW, THEREFORE, the City Council of the City of Kannapolis Resolves that:


- 1. The 163 square foot area currently part of the City public street system as shown on the Plat is no longer needed, used or benefits the City and is hereby released and abandoned.
- 2. The City Manager is hereby authorized to execute such additional documents, instruments, plats, site plans or other instruments as are necessary or required to memorialize this release and abandonment of the public right of way identified.
- 3. A certified copy of this Resolution shall be filed in the office of the Register of Deeds for Cabarrus County.


